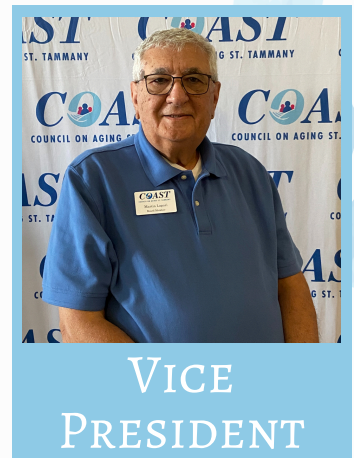
Joyce Donohue

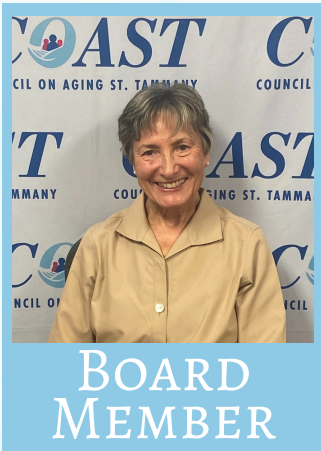
Kimberly Henry

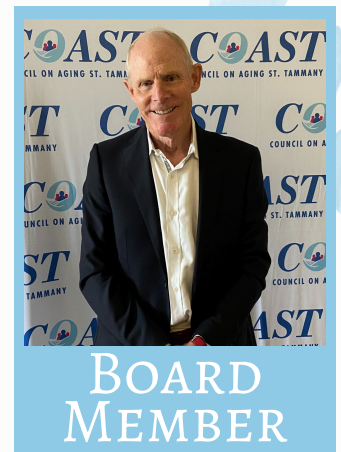


Jackie Landry
